JCAHO Redux - from the Editor

A number of PNC members have expressed interest in an on-going discussion of JCAHO issues. Nationally, many librarians have been sharing their experiences under the new standards on the Internet medical library discussion list, MEDLIB-L. I've given some thought to editing their postings (with permission of course) for inclusion in the newsletter, but I have a much better idea! Those of you with Internet access should experience searching a listserv's archives. You can retrieve everything on a topic, and I don't have to guess at your specific interests.

Searching a List's Archives

Every message posted to MEDLIB-L (or any listserv discussion group) is archived, and you can search and retrieve messages yourself. First, retrieve the instruction file that Charles Bailey created for searching PACS-L. Send a message to:

LISTSERV@UBVM (Bitnet) or
LISTSERV@UBVM.CC.BUFFALO.EDU (Internet)

In the body of the message (don't include a subject line) say simply **get search doc**

This will return a three-page document that giving explicit instructions, and numerous examples, for searching a list's archives. MEDLIB-L would be substituted for PACS-L in his examples. For the postings on JCAHO a search could look like:

It is wise to limit a search by date, and the Bailey document gives many examples. I chose to "print all" but, if your term is not very specific, or you think there is a great deal on a topic, you might substitute "index" for that line. This returns an index of relevant postings from which to choose.

Other terms I've recently searched: Physicians Online, benchmarking, table of contents, output measures.

NOTE: HLIB-NW IS NOT A LISERV.
This technique will not work for postings from our Northwest discussion list.

If you have problems or questions, contact your local computer guru or this editor. I will attempt to help! I can also name many others in the region who are becoming quite "command-line literate," including the PNC Automation Committee.

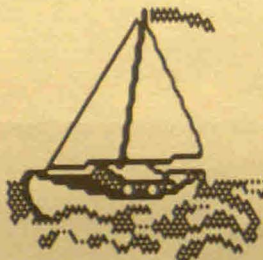

Funding Available for AIDS Outreach

NLM has issued an RFQ (Request for Quotations) to fund AIDS Information Outreach Projects. The primary purpose of these projects is to design local programs for improving information access for patients and the affected community as well as their care givers. Emphasis is on providing information or access to information in a way meaningful to the target community. At least one of the organizations managing the project must be a community-based organization or a public library. This is a tremendous opportunity for health libraries to link with organizations in your area and to provide leadership in training and disseminating much needed information. Projects will run for 18 months and budgets may not exceed \$25,000.

Proposals are due July 1,1994.

The NIH Guide for Grants and Contracts: Intent to Modify - from the NIH Gopher

The National Institutes of Health intends to modify the NIH Guide for Grants and Contracts on 1 August 1994. The format of Request for Applications (RFAs) and Program Announcements (PAs) will not be changed, but increased emphasis on electronic access of those documents will be implemented. The purpose of the changes is to improve the timeliness and accuracy of information dissemination and reduce production costs.

The current subscription list for the printed edition will be terminated. Currently, the printed edition includes notices, PAs, Notices of Availability (NA) of RFAs, and NAs of Requests for Proposals (RFP), and is mailed to approximately 34,000 subscribers. After 1 August, the printed edition will contain notices and brief NA/RFAs and NA/PAs. The NAs will include a brief summary of the purpose of the RFA or PA, the application receipt date, anticipated number of awards and funds available for RFAs, and information about how to obtain a copy of the RFA or PA. An electronic edition will include the contents of the printed edition and the complete text of PAs and RFAs. The NIH will send one copy of the printed edition to each major component of each institution, primarily to the Offices of Sponsored Research or the equivalent, and institutions not on the list of institutional contacts maintained by the NIH may request subscriptions.

The Montana Library Association Annual Conference was held in Butte, in the snow, April 24-27. The Health Sciences Interest Group ate well at Lydia's, a Butte restaurant known for its carbohydrates. Maryanne Blake and Linda Milgrom presented an internet class on accessing medical resources, Neil Rambo gave a presentation on the Pilot Connections Project followed by comments from Susan Long and Suzy Holt, and Nancy Press taught her disaster planning class. Susan Long chaired the business meeting of the Academic and Special Libraries Division and now passes the duties of running that division to Barry Brown.

Other noteworthy news...Leza Hamby is now a member of the WLN Board of Directors and also has a new part time assistant, Barbara Beardall. Kim Granath is a Senior Member of the Academy of Health Information Professionals.

News From Hospitals Around Idaho

Jan Walters at Mercy Medical Center in Nampa has moved the library into temporary quarters while work is completed on a new library facility. She is looking forward to opening the new library in late spring with expanded space and the addition of a consumer collection.

Kootenai Medical Center in Coeur d'Alene is planning a ground breaking for a new Health Resource Center which is expected to be opened in fall. This center will house a consumer library along with an auditorium equipped for interactive video and satellite, the social services and education departments, an employee daycare, a community sick child care and an adult respite care center. The staff of the professional library has begun providing consumer health information in the interim.

St. Alphonsus Regional Medical Center in Boise has networked the computers in the library and added an end-user station with Medline on CD-ROM. Judy Balcerzak says they plan to add an additional station in the physician's lounge as soon as they work out any problems. These are the beginning steps to networking the entire hospital and physicians' offices. Judy will take a 5-week leave this summer to attend the MLS program at the University of Arizona.

News From Washington *Submitted by Ellen Howard*

In March 1994, SERHOLD-participating libraries in Washington were awarded a federal grant of \$6,259 in Library Services and Construction Act funds by the Washington State Library Commission. For about a decade, the medical libraries in Washington, working cooperatively through the Washington Medical Librarians Association (WMLA), updated SERHOLD each year through a tape of downloaded serials holdings provided by the Western Library Network (WLN) into whose database all such holdings were entered. With the advent of direct SERHOLD updating in the fall of 1993 and a tape from WLN no longer required, WMLA librarians recognized that the impetus for maintaining current serials holdings in WLN might dissipate. With these grant funds, WLN will develop a computer program and other systems to allow for the electronic conversion and loading of our serials data from SERHOLD-produced tape to WLN. With this technology in place, libraries will have a seamless mechanism by which to keep current their serials holdings in this resource sharing tool so valuable for our region.

Subject: I'm moving to Denver

... I have accepted a job at Lutheran Medical Center. This community hospital is in the northwest corner of Denver in a suburb called Wheat Ridge. I'll begin on July 1st. The hospital is just part of their larger health-care organization which includes clinics throughout Denver, a psych hospital, homecare/hospice and either a skilled nursing facility or long-term care facility (I can't remember which!). The hospital is about 350 beds and is not a teaching hospital. Lutheran has just signed a Memorandum of Understanding with two other Denver hospitals (St. Joseph's where Margaret Bandy works, and Rose). They are beginning the process of managed care and by creating this link, hope to better position themselves for the future health care reform issues. Rose has a family practice residency - so I may get to work with them in the future! My plans include attending the Coeur d'Alene meeting - and I'm on the planning committee for the 1995 meeting - so I hope to see all of you then.

On the flip side Downsizing hit Virginia Mason Medical Center hard on May 19. They expect 100 layoffs in coming weeks. The librarian position held by Dani Haas was eliminated, effective immediately. Dani will be job hunting and is also available for temporary or fill-in work. Contact Ann Robertson or Linda Milgrom if you need her number. Ann is alone in the library but hopes to advertise a library tech position soon.

Fred Hutchinson has mounted their own gopher. It includes some unique information and is organized differently than many gophers. Library Services (Eve) has been one of two developers so the Library folders are extensive, although under continual construction. The address to gopher to is <gopher.fhrc.org>.

PNC Professional Development Fund

The PNC Professional Development Fund is designed to encourage participation in professional programs and courses by our members. The Board recognizes that meetings and courses are often too far away for many members to attend -- those who live in the major metropolitan areas have a distinct advantage. The aim of the fund is to improve access for members, and to equalize opportunities for attendance at programs and courses which improve members' professional development.

All applicants must adhere to the criteria listed below. The applications will be reviewed by the Executive Board, and all applicants will be notified of the Board's decisions. The deadline is at least six weeks before the event and grants will be funded in the order in which they are received. If two or more are being considered and there is not sufficient funding for all, the application with the earliest postmark that meets all the criteria will be funded first. At the Board's discretion, preference may be given to those who have not received a PNC scholarship in the recent past. The number of applications funded will be limited by the amount of funds set aside by the Board at the beginning of each budget year. This year the amount is \$500.

NOTE: Funds are reimbursed/disbursed to recipients after attendance at their selected meeting/program/course.

Criterion 1 PNC Membership

Applicant must be a current member of PNC.

Criterion 2 Number of Grants per Applicant

Applicants are eligible for a maximum of one grant per year.

Criterion 3 Number of Scholarships per Institution

No institution may receive more than one scholarship per event per year.

Criterion 4 Dollar Amount

A maximum of \$100.00 will be awarded per applicant. The grant will not exceed the actual expense associated with the meeting/program/course(s) for which the grant is requested.

Criterion 5 Matching Funds

No matching funds will be required of applicants.

Criterion 6 Subject/Content of Program/Meeting/Course

Professional Development funds are limited to professional programs, meetings, or continuing education courses sponsored by or co-sponsored by PNC and may not be requested or used for any other purposes.

The deadline for applications for fall '94 PNC/MLA is September 9, 1994.

Idaho News

Nola Higley at Magic Valley Regional Medical Center in Twin Falls is the new President of the Idaho Health Information Association. Her hospital has a new Internet node and is working out the technical problems of providing complete access. The hospital is working on a grant to link all of the Magic Valley hospitals electronically. Peggy Flowers at St. Joseph Regional Medical Center in Lewiston acquired the American Medical Association's Practice Parameters on CD-ROM recently. Staff are able to access this database as well as Medline and CINAHL at the library workstation.

Coleen Winward at the Eastern Idaho Regional Medical Center in Idaho Falls reports that her hospital is adding more services, so some of the departments, including the library, are losing space to make room.

To meet new demands for information St. Luke's Regional Medical Center library is developing a collection of patient education materials. The hospital is working on a hospital-wide network which will include physicians' offices and will provide access to the Internet.

Idaho Health Sciences Library at Idaho State University in Pocatello has developed a mission statement and collection development policy. They have begun providing services to the Idaho State Hospital South in Blackfoot and will also offer services to unaffiliated individuals.

Margaret Davis at Bingham Memorial has been offering Medline searching for about a year and is about to begin in-service for the staff on library services and Micromedex.

Washington News

UW HSLIC is also creating a gopher. Health Tracks is being developed by the IAIMS program and HSLIC to provide a single access point for a wide array of relevant, high quality information resources in the health sciences. The UW also hosted a visit from a group of Association of Canadian Medical Schools Librarians on April 26.

WSU Pullman has completed construction of the 'new' Holland Library. Moving the collection involved staff from all the libraries in one spirited, well-organized week. Limited renovations are now underway in the 'old' Holland.

The Intercollegiate Center for Nursing Education (ICNE) Yakima program will get a new, expanded facility and its enrollment will double as a result of a \$3.5 million capital appropriation passed by the Washington legislature. The new building, including a separate library space, will be located on the Yakima Valley Community College campus. Completion is scheduled for 1996.

PNC Funds at Work

The *Cunningham Memorial International Fellowship* is a four-month fellowship, offered by MLA, for health sciences librarians from countries outside the United States or Canada. It provides for observation and supervised work in one or more medical libraries in the U.S. or Canada and a limited amount of travel. PNC has contributed to this fund for a couple years and the following letter was received from MLA Headquarters after our most recent donation.
